INTRODUCTION

Côte d'Ivoire has been a country of destination of migration movements in West Africa. In recent years, it has increasingly become a country of immigration for young Ivorians. Today it is in the top five countries of residence for migrants what have reached the borders of the South of Europe. Côte d'Ivoire became an IOM Member State in June 2000 to assist the government and various stakeholders in managing migration flows as well as promote the wellbeing and dignity of migrants in and outside the country.

Côte d'Ivoire, popularly known as Ivory Coast, is a nation located in West Africa. It gets its name from the extensive ivory commerce throughout the 15th and 17th centuries. The country's major city and economic hub is the port city of Abidjan, while the capital, Yamoussoukro, is located in the country's center.

THE SYSTEM OF IMMIGRATION IN THE COUNTRY

It is not surprising to say that Ivory Coast is the first country of immigration in Africa Economic and political history reminds us that Ivory Coast is a country of migration. Its geopolitical position in the subregional space gives it a triple status of receiving, departure and transit territory for migrants to countries in the ECOWAS region and other countries of the North. Indeed, as a host territory, the abundant availability of land resources in the past and the orientation of an economic policy towards agricultural development constituted an attractive source of migrants from neighboring countries.



Recent data from Ivorian migration flows show that 10% of its population is made up of migrants, mainly from West Africa, let's say 2.6 million (IOM, 2020). In this migrant population, four ECOWAS members stand out for the proportion of their nationals. These are Burkina Faso (56%), Mali (19.8%), Guinea (5.8%), and Benin (2.7%) whose nationals are invested in the agricultural, fishing and industry sector.

THE DIFFERENT PURPOSES FOR WHICH A PERSON CAN IMMIGRATE TO THE COUNTRY

People immigrate to Cote d'Ivoire, also known as Ivory Coast, for various reasons, including economic, social, political, and personal factors. Here are some of the primary reasons for immigration to Cote d'Ivoire:



A. Economic Opportunities:

Cote d'Ivoire is one of the largest and most prosperous economies in West Africa, offering various economic opportunities. Immigrants often seek employment, investment opportunities, or to start businesses in the country.

B. Employment and Jobs:


D. Education and Research:

NON- DIRECT OR OTHER ROUTES OF IMMIGRATION TO THE COUNTRY

I. Family Reunification:

Family ties and reunification often drive immigration, where individuals may immigrate to Cote d'Ivoire to join family members already residing in the country.



II. Political Stability and Security:

Cote d'Ivoire has made progress in political stability in recent years, attracting immigrants seeking refuge from conflict or seeking a more stable political environment.

III. Quality of Life:

Individuals may immigrate to Cote d'Ivoire seeking an improved quality of life, better healthcare facilities, education systems, and overall living standards.

V. Cultural and Personal Reasons:

TYPES OF VISAS THAT ARE GIVEN FOR THE COTE D'IVOIRE

Cote d'Ivoire (Ivory Coast) Shortterm Visa

If you are planning a temporary visit to Cote d'Ivoire (Ivory Coast), you may apply for a short-term visa that allows you to stay in the country for up to 3 months. Short-term visas are suitable for individuals traveling for tourism, business, visiting family or friends, short-term education, exchange programs, short-term work, or other non-permanent reasons.




Cote d'Ivoire (Ivory Coast) Long-term Visa

A long-term visa for Cote d'Ivoire (Ivory Coast) is necessary for foreigners who plan to reside in the country for a longer duration. Even if your country is exempt from visa requirements, you will need to apply for a long-term visa before arriving in Cote d'Ivoire (Ivory Coast) if you plan to stay longer than the allowed period. However, in some countries, Cote d'Ivoire (Ivory Coast)'s official embassies and consulates don't process long-term visas, and visa applicants apply for short-term tourist visas instead. They can then apply for a residence permit after arriving in Cote d'Ivoire (Ivory Coast). This procedure can vary depending on the country of residence, nationality, and embassy policies.

E-Visa

Cote d'Ivoire (Ivory Coast) eVisa is an electronic visa that allows foreign nationals to apply for a visa to visit Cote d'Ivoire (Ivory Coast) online without having to visit an embassy or consulate. This visa is available for short-term stays of up to 90 days and is suitable for tourism, business, cultural, health, study, and other short-term purposes.

LICENSES AND DOCUMENTATIONS REQUIRED FOR IMMIGRATION



The requirements may vary based on your nationality, purpose of visit, and intended length of stay. To immigrate to Cote d'Ivoire, you will need to apply for a residency permit (titre de séjour) at the Office Identification Nationale. However, titres de séjour are not issued to children under the age of 16 who are documented on their parents' visas.

To enter Cote d'Ivoire, you will need a

- ·passport,
- ·visa, and
- ·proof of vaccination against Yellow Fever.

The e-visa is valid for tourism, business, medical, or study purposes, and is available for stays of up to 90 days.

To apply for a visa, you will need to fill out an application form, provide proof of travel arrangements, and pay the visa fee. It is recommended to apply for the visa 1-2 months before your travel date.

Additionally, you will need to fill out a Health Declaration Form before boarding your flight to Cote d'Ivoire, which is mandatory for all travellers

THE PROCESS TO APPLY FOR IVORY COAST IMMIGRATION VISA

1)Work permit form: If the applicant is moving to a foreign country for work-related purposes, then mostly, they have to fill the application form for a work permit or labor work.

2)Petition: After the approval of the application form for work, they have to fill Immigration petition form. The process has to be done online on the official government site of Ivory Coast or they have to visit the nearby embassy.


3)Processing: After the approval, your application form will be sent to the consulate of Ivory Coast for processing.

4)Petition approval: Wait for the approval of your petition.

5)Payment: You will receive an email on your e-mail ID after approval. Pay the required processing immigration fee for Ivory Coast. Applicants also have to pay the Affidavit form fee.

6)Submit Affidavit of Support form. the financial responsibility of the applicant to obtain the immigrant visa for the Ivory Coast.

7)Financial Documents- The proof of enough funds and other financial documents by the sponsor.
