Individuals who plan to stay in Myanmar for an extended period, such as for work, study, or long-term residency, may need to obtain additional permits or visas.

It is important for all individuals, whether visiting or intending to reside in Myanmar, to comply with the immigration laws and regulations of the country. This includes registering with local immigration authorities if staying in Myanmar for more than 90 days. Registration involves submitting necessary documents and completing the required paperwork to ensure compliance and avoid any potential issues during the stay.


SPECIAL ECONOMIC ZONES

KINDS OF VISA

BASED ON APPLICATION METHOD

REGULAR

These are obtained by applying directly at a Myanmar Embassy or Consulate in your home country or country of residence. Regular Myanmar Visas offer a wide range of visa categories to suit different purposes, such as tourism, business, education, and employment.

E-VISA

For a more convenient and streamlined process, Myanmar eVisa is an online visa application system available to eligible travelers. With eVisa, you can apply for your visa electronically without visiting an embassy or consulate. The application is submitted online, requiring essential information such as personal details, travel itinerary, and scanned copies of your passport bio page and a recent passport-sized photo. It is important to note that eVisa is applicable for tourism and business purposes only, and there are limitations on the permitted length of stay.

ON-ARRIVAL

For those who prefer a visa application process upon arrival in Myanmar, the country offers Visa On Arrival services at certain points of entry. Visa On Arrival allows travelers to obtain their visa upon arrival at the airport or land border checkpoint. This option is convenient for those who may not have had the opportunity to apply for a visa in advance.



BASED ON PURPOSE

- Diplomatic/official courtesy visa: This visa is granted to individuals who are traveling to Myanmar for official diplomatic purposes or on official government business. It is issued to diplomats, government officials, and their immediate family members.
- **Tourist visa**: The tourist visa allows individuals to visit Myanmar for tourism and leisure purposes. It is typically issued for a specified duration and allows single or multiple entries into the country.
- Business visa (single and multiple entry): The business visa is designed for individuals who intend to engage in business activities in Myanmar. It allows them to attend meetings, conferences, explore business opportunities, or establish business relationships in the country.
- Social visa (single and multiple entry): The social visa is intended for individuals who wish to visit friends or family residing in Myanmar. It allows them to stay for a specific duration to engage in social activities and reunite with their loved ones.
- Religious visa (single and multiple entry): The religious visa is granted to individuals who plan to visit Myanmar for religious purposes, such as attending religious ceremonies, participating in religious events, or undertaking religious studies.
- **Transit visa**: The transit visa is applicable for individuals who are passing through Myanmar to reach their final destination. It allows a short stay in the country while in transit.
- Official visa (single and multiple entry): The official visa is issued to individuals traveling to Myanmar on official government business or representing an international organization. It allows them to enter the country for specific official purposes.

- **Employment visa**: The employment visa is for individuals who have secured employment in Myanmar and intend to work in the country. It requires the sponsorship of the employing organization and the approval of the Ministry of Labour, Immigration, and Population.
- Education visa (single and multiple entry): The education visa is for students who have been accepted into an educational institution in Myanmar. It allows them to study and pursue their educational goals in the country.
- Journalist visa: Journalists and media professionals traveling to Myanmar for journalistic purposes require a journalist visa. It allows them to cover news events, conduct interviews, and gather information within the country.
- Crew visa (single and multiple entry): The crew visa is issued to crew members of airlines or shipping companies who are engaged in regular transportation services to and from Myanmar.
- Workshop/seminar/meeting/research Visa: This visa is for individuals attending workshops, seminars, meetings, or conducting research activities in Myanmar. It allows them to participate in specific professional or academic events.
- Entry visa (for diplomatic guests and non-diplomatic staff and their immediate family members) (Single and Multiple entry): This visa is granted to diplomatic guests and non-diplomatic staff, as well as their immediate family members, who are visiting Myanmar for official or personal purposes.



LICENSES & DOCUMENTATION

Diplomatic/official courtesy visa:

- Official letter/note verbal from the sending government/ diplomatic mission.
- Diplomatic passport or official/service passport.
- Completed visa application form.
- Two recent passport-sized photographs.

Tourist visa:

- Completed visa application form.
- Valid passport with at least six months of validity remaining.
- Two recent passport-sized photographs.
- Proof of travel itinerary, such as flight reservations or travel plans.
- Proof of accommodation arrangements, such as hotel bookings.

Business visa (single and multiple entry):

- Completed visa application form.
- Valid passport with at least six months of validity remaining.
- Two recent passport-sized photographs.
- Letter of invitation from a registered company/ organization in Myanmar.
- Company registration documents of inviting organization.
- Proof of business activities, such as trade contracts, conference registration, or meeting invitations.
- Financial documents showing sufficient funds to cover the trip.

Social visa (single and multiple entry):

- Completed visa application form.
- Valid passport with at least six months of validity remaining.
- Two recent passport-sized photographs.
- Letter of invitation from a Myanmar citizen or resident, specifying the purpose of the visit and the duration of stay.
- Copy of the inviting person's National Registration Card (NRC) or Passport.
- Proof of relationship with the inviting person, such as marriage certificate or birth certificate.

Religious visa (single and multiple entry):

- Completed visa application form.
- Valid passport with at least six months of validity remaining.
- Two recent passport-sized photographs.
- Letter of invitation from a religious organization in Myanmar, stating the purpose of the visit and the duration of stay.
- Copy of the registration certificate of the inviting religious organization.

Transit visa:


- Completed visa application form.
- Valid passport with at least six months of validity remaining.
- Two recent passport-sized photographs.
- Valid visa for the onward destination.
- Proof of confirmed onward travel, such as flight tickets or travel itinerary.

Official visa (single and multiple entry):

- Completed visa application form.
- Valid passport with at least six months of validity remaining.
- Two recent passport-sized photographs.
- Letter of request from the sending government or international organization.
- Official passport or service passport.

Employment visa:

- Completed visa application form.
- Valid passport with at least six months of validity remaining.
- Two recent passport-sized photographs.
- Job offer letter or employment contract from a registered employer in Myanmar.
- Copy of the employer's company registration certificate.
- Approved work permit from the Ministry of Labor, Immigration and Population.




