THE SYSTEM OF IMMIGRATION IN THE CENTRAL AFRICAN REPUBLIC

The Central African Republic ("CAR") follows a specific immigration system that governs the entry, stay, and departure of foreign nationals. The CAR immigration system is primarily regulated by the country's immigration laws, policies, and the Ministry of Public Security. The CAR has specific immigration rules and procedures designed to facilitate the entry of foreigners for various purposes.



DIFFERENT PURPOSES FOR IMMIGRATION

There are various reasons for which a person can immigrate to the Central African Republic:

- Work and Employment:
 Individuals seeking work
 opportunities, temporary or
 permanent, in the "CAR" may
 apply for the appropriate
 work visa or permit.
- Business and Investment:

 Foreign investors and entrepreneurs intending to establish businesses or invest in the country may apply for business visas or permits.
- Study and Research:
 Students and academics
 looking to pursue education
 or conduct research in the
 "CAR" can apply for study
 visas.






- Family Reunification: Foreign nationals who have family members residing in the "CAR" may apply for family reunification visas.
- **Tourism and Visit**: Foreigners visiting the "CAR" for tourism, short visits, or cultural exchange can apply for tourist visas.
- Diplomatic and Official Visits:
 Government officials, diplomats, and representatives of international organizations can enter the "CAR" with appropriate diplomatic or official visas.

NON-DIRECT OR OTHER ROUTES OF IMMIGRATION

Apart from the standard immigration routes mentioned above, the "CAR" may have specific programs or provisions for special circumstances, such as refugee resettlement, humanitarian visas, and asylum seekers.



TYPES OF VISAS

The Central African Republic offers various types of visas depending on the purpose and duration of stay. The common types of visas include:

- Tourist Visa: For shortterm visits and tourism purposes.
- Business Visa: For individuals engaged in business activities.
- Student Visa: For students enrolled in educational institutions in the CAR.





- Work Visa: For foreign nationals authorized to work in the CAR.
- Family Reunification Visa:
 For joining family members
 residing in the CAR.
- Diplomatic/Official Visa:
 For government officials,
 diplomats, and
 representatives.

LICENSES AND DOCUMENTATIONS REQUIRED FOR IMMIGRATION

The specific documentation and licenses required for immigration to the Central African Republic may vary depending on the purpose of entry and the applicant's nationality. However, some common documents may include:

- Passport: Must be valid for at least six months beyond the intended stay.
- Visa Application Form: Filled and signed by the applicant.
- Passport-sized Photographs: As per the specifications of the CAR authorities.
- Proof of Sufficient Funds: To cover living expenses during the stay.
- Letter of Invitation: If applicable (for business, family, or official visits).
- Educational Documents: For students and academics.
- Work Contract: For work visa applicants.



RECENT CHANGES IN IMMIGRATION RULES

The Central African Republic's authorities create and enforce entry requirements. If you have any questions about the Central African Republic's admission regulations, please contact its UK embassy, high commission, or consulate.

Proof of vaccination and COVID-19 testing requirements vary depending on the destination country's policy. Before leaving the Central African Republic, travelers should check the regulations of their destination country.



If you have received complete vaccination against COVID-19, you must present proof of vaccination upon arrival in the Central African Republic.

For those who are not fully vaccinated, it is required to provide a PCR test conducted within 72 hours prior to arrival.

Children and young individuals are subject to the same guidelines and requirements as adults.

Before traveling, ensure that your passport and travel documents are valid. Your passport should have a validity of at least 6 months from your arrival date.

To enter the Central African Republic, British nationals must obtain a visa. Contact the CAR Embassy in Paris at 30 Rue des Perchamps, 75116 Paris, for visa application and additional entry requirement information.

A valid yellow fever vaccination certificate is mandatory for visitors entering or transiting through the Central African Republic. Ensure you possess a valid certificate.
